3.2 ADDITIONAL ELIGIBILITY CRITERIA

3.2.1 BID NO. W/ONB/ORC-61/2018/19

Bidders who complied with all the eligibility criteria will be evaluated on the additional eligibility criteria based on the bid condition information requested in the Bidding document.

Under this category, the following additional eligibility criteria were evaluated:

- ◆ All pages must be initialised.
- ◆ Bid amount in Numbers and Words must be on the front page.
- ◆ Bid document must be completed in Black Ink.
- ◆ All correction must be initialised.
- ◆ No fluid eraser used.
- ◆ Bid Documents signed where necessary.
- ◆ Addendum No 1. must be attached.
- ◆ Business principal must be in line with the Project.

3. EVALUATION OF BIDS

3.1 ELIGIBILITY COMPLIANCE

3.1.1 BID NO. W/ONB/ORC-61/2018/19

The Bidders were screened and checked for general compliance with regard to the requirements of the Bids. Table 2 presents the completeness of the eligibility compliance information submitted by Bidders.

The Bid Evaluation criteria were comprised of:

- ◆ Good Standing Certificate from Social Security Commission
- ◆ Good Standing Certificate from Inland Revenue
